Applications are invited from eligible candidates for filling-up 15\*\* vacant positions of Guest Faculty for afixed duration as prescribed by University of Delhi.

#### **Essential Educational Qualifications:-**

The qualifications for Guest Faculty will be the same as those prescribed for Assistant Professor of the University as per UGC's Regulations, i.e.

 Good academic record as defined by the University with at least 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) at the Master's Degree level in a relevant subject (Chemistry) from an Indian University or an equivalent degree from an accredited foreign University.

2. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET), conducted by UGC or CSIR\*

- 9. No TA/DA will be paid by the Department for attending the interview.

## **GENERAL NOTE:**

- The candidates who have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards & Procedure for Award of Ph.D. Degree) (i) Regulations-2009, shall be exempted from the requirement of the minimum eligibility condition of NET for appointment of Assistant Professor or equivalent positions in University/Colleges/Institutes. Provided further, the award of degree to candidates registered for the M.Phil/Ph.D. programme prior to 11<sup>th</sup> July-2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institutions awarding the degree and the Ph.D. candidates shall be exempted from the requirement of NET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutes, subject to the fulfilment of the following conditions:-
  - (a) Ph.D. Degree of the candidate awarded in regular mode only;
  - (b) Evaluation of the Ph.D. thesis by at least two external examiners;
  - (c) Open Ph.D. viva-voce of the candidate had been conducted;
  - (d) Candidate has published two research papers from/based on his/her Ph.D. work, out of which at least one must be in a refereed journal;
  - (e) Candidate has made at least two presentations in conference/seminars, based on his/her
  - Such candidates must upload the NET Exemption certificate signed by a competent authority in place of the NET certificate.
  - A relaxation of 5% may be provided at the Graduate and Masters Level for the Scheduled Castes/Scheduled Tribes/Differently-abled (Physically and Visually differently-abled) / Other (ii) Backward Classes (OBC - Non-Creamy Layer) categories for the purpose of eligibility and for assessing good academic records during direct recruitment to faculty positions. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace mark procedures.
  - A relaxation of 5% may be provided, from 55% to 50% of the marks to the Ph.D. Degreeholders, who have obtained their Master's Degree prior to 19th September-1991. (iii)
  - Relevant grade, which is regarded as equivalent of 55% wherever the grading system is followed by a recognized University, shall also be considered eligible. (iv)
